1. Introduction

This Privacy Policy outlines how Kenbu Dojo ("We", "Us", "Our") handle personal data in accordance with the General Data Protection Regulation (GDPR) (EU) 2016/679. We are committed to protecting your privacy, maintaining your trust and confidence, and preserving your rights and freedoms by handling your data responsibly.

2. What Information We Collect

We collect various types of personal data, including:

- Personal identifiers such as name, date of birth, gender
- Contact details like address, phone number, email address
- Health data, required to ensure your safety while participating in our activities
- Images or video footage for historical, promotional or safety purposes
- Payment details, if you are purchasing from Kenbu Dojo directly

3. How We Use Your Data

We use your data to:

- Register you as a member and administer your membership
- Communicate with you regarding club events, updates, and other relevant information
- Ensure your safety during club activities
- Process payments and for financial audit purposes
- Promote our club, only with your explicit consent

4. Lawful Basis for Processing

Our lawful bases for processing your personal data include:

- Performance of a contract with you
- Compliance with a legal obligation
- Protection of your vital interests
- Consent, where we have obtained your explicit consent

5. Sharing Your Data

We do not share, sell, or distribute your data to third parties unless required by law or necessary to fulfil our contractual obligations to you. In such cases, we ensure all third parties respect your personal data and comply with all relevant data protection laws.

Full Data is accessed only by the Head Instructor and assistant instructors within Kenbu Dojo when necessary or required when covering lessons/events.

All students Names, Date of birth and any medical conditions are disclosed to BMABA for registering student insurances each year.

6. Your Rights

As a data subject, you have the following rights under the GDPR:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure
- The right to restrict processing
- The right to data portability
- The right to object
- Rights in relation to automated decision making and profiling

7. Data Retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for. To determine the appropriate retention period, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure, the purposes for which we process your personal data, and whether we can achieve those purposes through other means.

8. Data Security

We are committed to ensuring your data is secure. We have put in place appropriate physical, electronic, and managerial procedures to safeguard the information we collect.
